Undersigned agrees to indemnify, hold harmless, board **Weld County Fish and Wildlife, and its members** (**Hereinafter referred to as "WCFW"**) from any and all fault, costs, expenses, claims, demand or lawsuits arising out of, related to or connected with the undersigned's presence at and/or participation in competition shooting; the discharge of firearms by Undersigned; Undersigned's presence on or use of the range, building, land and premises ("Premises").

Undersigned furthermore waives for himself and for his/her executors, personal representatives, administrators, assignees, heirs and next of kin, any and all rights and claims for damages, losses, demands and any other actions or claims whatsoever, which he/she may have or which may, in any way, arise out of, be related to or be connected with; WCFW FUND; the Premises, including any latent defect in the Premises; Undersigned's presence on or use of said Premises; Undersigned's property (whether or not entrusted to instructor); and, the discharge of firearms. WCFW shall not be liable for, and Undersigned, on behalf of assignees, heirs and next of kin, herby expressly release WCFW from any and all such claims and liabilities.

Undersigned hereby expressly assumes the risk of taking part in competition shooting and taking part in the activities on any Premises which include, but are not limited to, instruction in the use of firearms, the discharge of firearms and the firing of live ammunition.

Undersigned hereby acknowledges and agrees that Undersigned has read this instrument and understands its terms and is executing this instrument voluntary. Undersigned furthermore hereby acknowledges and agrees that he/she has read, understands, and will abide by all range rules and procedures and any other rules and procedures stated by the WCFW.

Undersigned expressly agrees that this instrument is intended to be as broad and inclusive as permitted by law, and that if any provision of this instrument is held invalid or otherwise unenforceable, the enforceability of the remaining provisions shall not be impaired thereby. No remedy conferred by any of the specific provisions of this instrument is intended to be exclusive of any other remedy, and each and every remedy shall be cumulative and shall be in addition to every other remedy now or hereafter existing at law or in equity or by statute or otherwise. The election of anyone or more remedy hereunder by WCFW shall not constitute any waiver of WCFW's right to purse other available remedies. This instrument binds Undersigned and his/her executors, personal representatives, administrators, assignees, heirs and next of kin.

Undersigned states that he/she has never been convicted of a crime of violence and can legally own and possess firearms.

Any use of the WCFW funds not used as intended will result into the undersigned's liability to repay the fund back to WCFW.
